MISSION

It is the mission of Apalachee Center, Inc., to empower persons served to improve the quality of life for themselves and their families through the provision of quality behavioral health care with unrelenting attention to clinical excellence and safety.

STAFF

Employees include psychiatrists, psychologists, nurse practitioners, social workers, counselors, addictions professionals, care managers, nurses, certified nursing assistants, recovery coaches, patient care specialists, behavioral specialists, and mental health assistants.

FEES

Payment for services is accepted from clients, most private insurance companies, Preferred Provider Organizations, Champus, Medicare and Medicaid. Required co-payments apply to some services and are based upon insurance company coverages and/or ability to pay (i.e., sliding fee scale). The State of Florida Department of Children and Families and local County Commissions provide some funding for designated programs to assist eligible clients in need.

HISTORY

Apalachee was organized in 1948 as the Human Relations Institute of Leon County and has since expanded to include offices in seven surrounding counties. The Center is a private, not-for-profit organization governed by a volunteer Board of Directors.

DIRECTORY OF SERVICES

INPATIENT SERVICES

Central Receiving Facility: Provides assessment and referral services twenty-four hours a day for mental health and substance related crises.

Eastside Psychiatric Hospital (32 bed): Provides short-term comprehensive psychiatric inpatient treatment for persons experiencing an acute mental health crisis; 20 bed adult unit and the BEACH unit, a separate 12 bed unit serving youth 6 - 17.

PATH Crisis Stabilization Unit (24 bed): Provides short-term inpatient stabilization services for persons experiencing a mental health crisis.

Primary Care Center Detox Unit (14 bed): Provides short-term medically-supervised alcohol and drug detoxification, assessment, education and referral.

Short-Term Residential Treatment Program (8 bed): SRT program provides intensive treatment for persons experiencing a mental health crisis who are in need of a longer stay alternative to hospitalization.

RESIDENTIAL

Gadsden County (Two 16-bed Residential Facilities) & Leon County (Two 16-bed and one 8-bed Residential Facilities): Provides a 24-hour supervised, structured residential placement for adult males with severe and persistent mental illness with legal system involvement. Services include competency restoration, court liaison services, legal advocacy, psychiatric treatment, therapy, psychosocial rehabilitation, nursing, and coordination with appropriate agencies (DCF, courts, other Districts) for transition into independent living.

Madison Group Home Residential Facility (16 bed): Provides a 24-hour supervised, structured residential placement for adults with severe and persistent mental illness. Services include psychiatric treatment, psychosocial rehabilitation, therapy, and case management.

Satellite Apartments (16-bed): Provides placement and lease management coordination for adults with severe and persistent mental illness in need of transitional living arrangements. Services include psychiatric treatment, psychosocial rehabilitation, therapy, and case management, with an emphasis on employment.

Transition Home Residential Facility (16 bed): Provides short-term residential treatment for those individuals who are being stepped down / diverted from state psychiatric treatment facilities. Services include psychiatric treatment, therapy, psychosocial rehabilitation, nursing, and case management.

OUTPATIENT RECOVERY SERVICES

Adult Outpatient Services: Services are aimed at supporting self-directed recovery. Services include assessment / evaluation, psychiatric treatment, case management, psychosocial rehabilitation, co-occurring and substance use treatment and individual and family therapy. Medications Assisted Treatment (MAT) is available in Leon County.

Bradley REACH@Apalachee Center: Adolescent Virtual Intensive Outpatient and Partial Hospitalization Program. These programs are a partnership between Bradley Hospital and Apalachee Center.

Children's Outpatient Services: Services include psychiatric evaluations, medication management, individual and family therapy and case management. Services are individualized to meet the needs of the family.

Community Action Team (CAT): Provides intensive community-based services for youth and their families who have not achieved their desired outcomes from "traditional" approaches to treatment.

Community Forensic Services: Assessment, medication management, case management and competency restoration services provided to individuals in the jail, who have court involvement or are on probation and parole.

Drop-In Center: The Drop-In-Center offers a community meeting place for present or former consumers of mental health services and their families. Focus is on self-help with social, recreational, and support activities.

FACT: Florida Assertive Community Treatment Program provides intensive community-based therapy, rehabilitation, and supportive services for persons with severe and persistent mental illness in Leon County.

FIRST Team: The Forensic Intervention and Re-entry Services Team (FIRST) serves adults who have a mental illness and are involved with the criminal justice system in Leon County. Individuals are served at every stage of the criminal justice process—pending, incarceration, mental health pre-trial release, and mental health probation or conditional release.

FSU BH@Apalachee Center: Provides psychiatric and psychotherapeutic assessment and treatment services to clients aged 6 and above. This clinic is a partnership between Florida State University and Apalachee Center.

Homeless Project: The Homeless Project provides outreach, mental health case management, and psychiatric / medication management services for homeless persons with severe mental illness.

Mobile Response Team: Provides 24/7 crisis intervention services in the community.

NAVIGATE Program: Navigate is a comprehensive treatment program, created to provide early treatment for people who have experienced a first episode of psychosis.

Primary Care Services: Provides primary medical care to current Apalachee clients on site at the Leon, Gadsden, and Madison County Outpatient Clinics.
